11.12.28	<p>Dog Control Orders</p> <p>P. Cnllrs considered the proposals from WC and following a discussion on potential enforcement issues, including providing the opportunity for the PC to enforce orders in the future, resolved to request that WC include a requirement for dogs to be kept on leads while on the KGVth and Lower Recreation Ground playing fields.</p> <p style="text-align: right;">Proposed DC/ seconded TJB /unanimous</p>	Clerk
11.12.29	<p>High Street Parking Restrictions:</p> <p>Cnllrs were informed of instances of residents habitually parking in bays intended to assist with commercial activity during business hours. P.Cnllrs felt that the abuse was not helped by the faded line markings in the High Street as a whole and also by a decision made by the PC some 8 or 9 years ago that requested lenient enforcement action in the top end of the High Street.</p> <p>A resolution to remind all residents and businesses on the High Street (by letter) that enforcement was now a possibility was not agreed.</p> <p style="text-align: center;">Proposed PeterC / seconded MissFC / 4 in favour with 5 against</p> <p>P.Cnllrs did however resolve to undertake that a 2 part process be implemented:</p> <p>a. a letter be sent to all residents and businesses on the High Street reminding them of the problems and issues around parking along the High Street and requesting that neighbourly behaviour and consideration should be upmost in the parking of any vehicle.</p> <p>b. if no improvement results, WC will be requested to enforce parking restrictions on a regular basis throughout the village.</p> <p style="text-align: right;">Proposed MrsJA / seconded DC / unanimous</p>	Clerk
