

## TISBURY PARISH COUNCIL

Minutes of the Interim Meeting held on Tuesday 17<sup>th</sup> August 2010  
at 6:30pm in the Elizabeth Hall, Tisbury.

10.08.08 **Present:** P.Cnllrs P. Duffy (Chairman), D. Carroll (Vice-Chairman), J. Berkley-Matthews (RFO), Mrs J. Amos, Mrs P. Chave, P. Coopman, Miss F. Corp, R. Dearden and M. McGrath - 9.

Also in attendance: Mrs S. Harry (Clerk).

**Apologies received and accepted:** WCnllr TD.

10.08.09 **Declarations of Interest:** None.

10.08.10 **Public Participation:** None.

Items for the remainder of the meeting were taken out of order to accommodate the potential attendance of various parties.

10.08.11 S/2010/1100 - WCM - Upper Chicksgrove, Tisbury - Retention of stone processing and storage area including all buildings, plant and structures until all permitted reserves at Chicksgrove Quarry and its extensions are exhausted

Following a brief discussion P.Cnllrs resolved to support the application.

**Proposed DC/ seconded MMcG / unanimous**

S/2010/1121 - full - 23 Lady Down View Tisbury Salisbury - conversion of part of lower ground floor from garage to habitable room and alterations to fenestrations

P.Cnllrs resolved to support this application, noting that the proposals made much better use of the space available.

**Proposed RD/ seconded MissFC / unanimous**

S/2010/1150 - land at Ladydown View, Tisbury - T4 ash coppice at 5' and T5 elm fell

As the Village Tree Warden (VTW) was still in discussion with the WC Tree Officer on these proposals, P.Cnllrs resolved to delegate the decision to the Clerk (who would take into account the VTW's recommendation).

**Proposed MissFC / seconded PC/ unanimous**

Draft Composting Site Planning Application - P.Cnllrs discussed the draft proposal at some length, especially with respect to the hours of operation of the shredder and the pros and cons between a 2m or 4m housing for the shredder. Public safety issues were also explored and various amendments made, including the window of operating times for the shredder, i.e. Monday to Saturday between 8am and 6pm for no more than 2 days in any week.

It was noted that the proposed application concerned 2 elements of the site; the use of the shredder and its hours of use along with the increase in the number of composting bins. It was suggested that if there were any doubts expressed by WC Officers during the informal pre-submission discussions on just one element of the combined proposal, the application would be separated and each element submitted independently of the other.

10.08.12 **CONSIDERATION OF TISBURY PC FINAL RESPONSE TO**

**WILTSHIRE COUNCIL'S PARKING STRATEGY** - Cnllrs considered the previously circulated draft response and made various changes to wording and spelling etc. before resolving to submit the revised document. (The final response is attached as a part of the minutes)

**Proposed DC / seconded RD/ 8 in favour with 1 abstention (not present at original discussion)**

**10.08.13 Feedback on meeting between WCnllr Dick Tonge (with Ian Brown) and Patrick Duffy (with the Clerk)**

P.Cnllrs were told of the meeting above that had been arranged by WC to discuss the possibility of the PC assuming responsibility for the car park. Although there would be little in the way of cost savings for WC (approx £2,000 p.a. plus capital works every 30 years), the potential car parking charges (currently being discussed) would likely have a detrimental impact on the High Street and its employees. A robust discussion between the WC and PC representatives explored various scenarios and the WC expressed thanks for being able to meet and having the face to face opportunity to hear TPC's views. Any agreement would be on a 10 year self repairing lease basis and WC had not considered alternative arrangements such as recharging costs to the PC or reducing the council tax levied on Tisbury residents in exchange.

HOWEVER, WC suggested that there might be an opportunity for some negotiation should TPC wish to assume responsibility for the public toilets. A discussion of some length ensued, with P.Cnllrs proposing that the Clerk should indicate the willingness to proceed with discussions, but that any decisions would need to be brought back to a full PC meeting before any related decisions were made.

**Proposed PD/ seconded MissFC / unanimous**

**10.08.14 Letter to Dr Murrison from resident of Tisbury (West) with respect to the Hindon Lane development**

P.Cnllrs discussed the contents of the copy letter to the PC and asked that the Clerk contact the residents to explain the current position.
