Dear Street Trading,

I note that you have not extended to me as the area highway engineer for the Tisbury area, the courtesy of being made aware of this application. Luckily my technician was able to address that shortfall!

I am very familiar with the location suggested and have witnessed on a number of occasions over the years, HGVs in particular having difficulty in negotiating this junction, where road space is already constricted due to it's historical layout, with the central presence of the "stone", as well as prolific parking at every edge of the carriageways here, on a regular basis.

Therefore as a result of the proposed siting of the vendor's trading van effectively right on the junction, including within the sight lines for forward visibility of the same; as well as the potential of customers (socially distanced) queuing around it on the narrow footway and carriageway, **I am as a result unable to give the Highway Authority's consent for the application, at this location, on the grounds of highway safety.**
