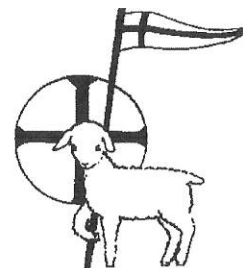

Application for a Grant/Donation

Further to our emails, please find enclosed a completed application form with regard to a grant/donation from the Parish Council.

In past years, grants from the Parish Council have been made to the Church specifically for the upkeep of the clock, without formal application from the Parochial Church Council. Presumably, procedures have changed.

The Parochial Church Council would be most obliged if the Parish Council could give consideration to its request. Accounts for the year ending 31st December 2019 are enclosed and were signed off at the Annual Parochial Church Meeting held on Wednesday, 28th October 2020. We would point out that the Church was only able to meet half of its obligation to pay the parish share to the Diocese of Salisbury in that year and this year is even more difficult. With the closure of churches this year and the inability to hold fund raising events, the church's income has been substantially diminished.
