b. Future Planning Developments

i. Potential move of Co-op Stores to South Western Hotel site – no information had been received from the Co-op's representative and it appeared likely that the move may have been thwarted for legal reasons.

ii. Station Works site

Following receipt of an email from Simon Trueick of Intelligent Land, the original intention of the Joint Working Group (JWG) to opening a dialogue to discuss alternative ideas for, as examples, both vehicle access and pedestrian access, has been overtaken by the intent of Intelligent Land to open public consultation, primarily using a dedicated website on Friday 7th May; letter drops to all homes will also be made.

Addition to Skate Park – councillors were referred to the photograph of a recently added 'improvised' grind rail at the entrance to the bowl. The Clerk has consulted the insurers that are happy to accommodate as a part of the policy subject to a risk assessment being available, but councillors resolved to have the item taken away in order to discourage other 'additions'.

Parking on double yellow lines adjacent to Fishmonger shop - councillors agreed to take further advice on other possible solutions from the CATG Engineer; this was thought preferable in the short term as the introduction of yellow crossed hatching would have an impact on the parking for Co-op delivery lorries that blocked the High Street when legitimate on-street parking was not available. *Clerk
