Questions or Statements from Members of the Public:

A member of the Neighbourhood Planning Group emphasized the importance of reviewing and renewing TisPlan that would be 2 years old in November 2021. Suggestions were made for professional help that could be used to help with press coverage/social media and planning issues.

Report from Wiltshire Councillor – the Chairman introduced Nick Errington as the newly elected Wiltshire Councillor:

- a. Although Wiltshire Council remained under Conservative Party control, there were now 27 Liberal Democrat councillors, 17 Independent councillors and 3 Labour councillors; the Leader of the Council is now Richard Clewer.
- b. The Garden Waste service would re-start at the end of June at a cost of £50.
- c. Libraries would re-open on 25th May, with Tisbury limited to Tuesday and Friday afternoons between 2pm and 4pm.
- d. The election for the new Police and Crime Commissioner for Wiltshire would be held on 19th August 2021, following the non-eligibility disclosure of Jonathan Seed.

b. Future Planning Developments / Statements – resolutions may be required

- i. Potential move of Co-op Stores to South Western Hotel site – no additional information available.
- ii. The Nadder Centre – Wiltshire Council has confirmed that a lease is about to be signed for the use of 1 office and 1 treatment room by a local practice – the Orchard Practice (part of Sarum West PCN).
- iii. The Former Sports Centre – The potential joint development between Nadder Community Land Trust and Wiltshire Council's Stone Circle is finally beginning to materialise. An agreement has been reached to ensure 5 houses will be available for rent to local families, and it is likely that Wiltshire Council will apply for 'Brownfield Release Funds' that will enable demolition of the existing building and guaranteed funding (50%) for residential housing as identified in a neighbourhood plan.
- iv. Updating the Tisbury Parish Council Vision Statement 2014 – the Clerk explained that such documents are something that will be expected of Councils in the future and used as a measure of engaging with the community, i.e. transparency. Although not essential at the present time, it is likely that audit priorities for the future will look at what is currently provided and how often it is updated, in tune with neighbourhood plans etc.

An initial assessment at the meeting by councillors identified the following areas that could be updated:

Diversity and Youth issues

Education

Rural sustainability

Digital training.

Parking on double yellow lines adjacent to Fishmonger shop – Councillors noted that advice had been sought from South West Wiltshire Area CATG Officer regarding potential solutions that would not cause difficulty for the Co-op lorry and hence more congestion on the High Street. The response will be circulated once received and or be on the next available agenda.
