The effect of the order will be to divert the public footpath at Wardour School running from OS Grid Reference ST 9251-2741, south of the C.61 road, in a south-easterly direction for approximately 77 metres, before leading north-east, adjacent to the school playground for approximately 42 metres to OS Grid Reference ST 9260-2738, having a width of 4 metres on that section between OS Grid Reference ST 9257-2735 and OS Grid Reference ST 9260-2738, to a line running from OS Grid Reference ST 9251-2741, south of the C.61 road, in a north-easterly direction parallel to the C.61 road for approximately 50m, before leading south-east for approximately 84 metres and then south-west for approximately 2 metres to OS Grid Reference ST 9250-2738, having a width of 2 metres on that section between OS Grid Reference ST 9251-2741 and OS Grid Reference ST 9255-2744 and 3 metres on that section between OS Grid Reference ST 9255-2744 and OS Grid Reference ST 9260-2738, as shown on the order map and to change the Mere and Tisbury Rural District Council Area Definitive Map and Statement dated 1952 accordingly.
