Questions or Statements

a. A resident of Stubbles raised 3 issues:

- the number of trees in the River Nadder between the Station Road and Tisbury Row bridges. The Clerk indicated two of the trees had fallen from Tisbury Council land, but the remaining trees had fallen from privately owned land. The Clerk intended to approach the land owner with a view to requesting help with a joint exercise to remove the trees.
- during the October flood, the chicken wire fence between the football pitch and Lower Recreation Ground play area collected a large amount of flood debris that eventually toppled/ flattened the fence with the force of water. The resident suggested that fencing with larger apertures could be considered; **Clerk to action.**
- strimming activity on the river banks in the Stubbles area was highlighted as the arisings were being left on the banks and rotting, becoming slippery and hazardous to anyone walking on the banks; **Clerk to action.**

The Chairman also reminded everyone that the report from Wiltshire Council on the October flooding event was still awaited.

b. Parish Councillor FC produced a photograph of the original position of the plank bench (recently removed from the junction of Vicarage Road and the High Street).



c. A resident of Vicarage Road highlighted a problem recently encountered with the planning system, i.e. no notification of a planning application, the site of which was in the direct line of sight from the resident's home. Other closer residents had been notified, but did not have a direct line of sight from their properties with what was considered a structure too tall and bulky in an AONB.

Report from Wiltshire Councillor – Councillor NE reported on the following:

a. the next Full Wiltshire Council meeting will be on 15/02/2022 to discuss a projected shortfall of £27million even following a 1.99% increase on Council Tax (maximum permitted) and a 1% social care levy. Likely areas to achieve savings are car park charges, waste collection and staff reductions.

b. the Cabinet meeting today had discussed a Green strategy and general waste; the full agenda is on the website, with minutes to follow.

c. It was noted that investment in schools were funded from central government and, for example, Mere would be benefitting from 105 additional places.

Wiltshire Councillor NE indicated that the Planning Officer had agreed to meet with the affected resident on site and that the resident's objection had been added on the Wiltshire Council Planning Portal; so ensuring the resident's objection be fully considered.

b. Other Planning Matters:

- i. **Updating TisPlan (Neighbourhood Plan)** – Councillor GM reported that a first meeting of the Review Group had been held. An action list and project programme was now available with a key priority being public consultation.

- ii. **Events for the Platinum Jubilee** – Councillors noted the suggestions to date:
- Involving the Carnival Committee and/or New Vic Halls
 - Tree planting
 - Happy Hookers crochet display
 - High Street lunch/tea party
 - Bicycle Parade
 - Cake Competition
 - An oak tree in the Jubilee Meadow – position identified by Village Tree Warden
 - Lighting of a Beacon
 - Freedom of the Village Event

Additional suggestions were:

Hanging basket and window box competitions

Village Champion Awards – to be continued as an annual event

It was noted that a decision on a road closure will need to be taken soon or an alternative location suggested.

Also that funding from an Area Board Grant would be limited, if any, and fund raising initiatives, as used for the Diamond Jubilee, would be an alternative.
