

PL/2021/06853 - Barn West of Prospect Cottage, Hindon Lane, SP3 6QQ (03.11.21) The conversion of existing stone barn into a dwelling and erection of cart shed utilising existing Chilmark stone on the site from a former small barn to provide bat accommodation

PL/2021/07526 - South Western Hotel, Station Road, Tisbury, SP3 6JT 22.09.21 Change of use of vacant public house with guest bedrooms (sui generis) to retail (Class E) with single storey rear extension; conversion of first floor to create 3 no. flats (Class C3); installation of plant and machinery; and ancillary car parking and delivery area
