Items for Information / next agenda

- a. **Bench replacement at Vicarage Road/High Street junction** – a response from the Streetscene Manager indicates that the bench is an un-funded asset that will be removed completely due to the dangerous condition. An alternative location for a 'like for like' bench – see available document – has been suggested by the Wiltshire Council Streetscene Manager; if this is acceptable to councillors, then the Area Highways Manager will fund the necessary utility search and the council would fund the replacement bench.
- b. **Replacement Internal Auditor** – councillors will remember that the Internal Auditor for the past 2 years has moved on the greater things and a replacement needs to be found.
- c. **Trellis House** – the Catholic Church has indicated that a revised planning application for the Trellis House site is now underway. The Clerk advised that gaining pre-application advice from Wiltshire Council would be preferable before any discussion with councillors as a part of a public agenda.
