**Prior to the official start of the meeting, Councillors held a one-minute period of silence in support of the residents of Ukraine.**

**Furthermore, Councillors supported the statement issued on 24 February 2022, endorsed by the Local Government Association, by the Council of European Municipalities and Regions (CEMR), strongly condemning the multiple attacks and violations of the territorial integrity and sovereignty of Ukraine. CEMR also expressed their full support and solidarity to the Ukrainian people and their peers in local and regional government.**

### **Questions and Statements from the Public – none.**

**Report from Wiltshire Councillor** - Wiltshire Councillor Errington highlighted a number of items discussed at a meeting with the Wiltshire Council Street Scene Team:

- a. With respect to cutting verges, the Tisbury area is designated as 'rural' and as such will leave many verges uncut until September to support the wild flower blooming season. Any narrow lanes or verges around road junctions with limited visibility will be cut as usual in May/June.
- b. Wiltshire Council had suspended all recycling collections until 21<sup>st</sup> March due to industrial action taken by workers employed by Hill's Waste Ltd.
- c. Highways England would be looking to improve the A36 between on the Southampton Road from Salisbury.
- e. £5,000,000 had been allocated to a South West Energy Hub to provide assistance to residents without mains gas or in areas of social deprivation etc.

#### PLANNING MATTERS

##### a. Current applications:

**PL/2022/00855** - Tisbury Sports Centre, Weaveland Road, TISBURY, SP3 6HJ  
Demolition of former sports centre (class E(d)) involving redevelopment to form 13 no. dwellings (class C3) & associated works.

The discussion centred on the Letter of Intent from Stone Circle Ltd, received after a long delay, the legal process now necessary to create a vehicle to own the land in perpetuity on behalf of the community, the management of the land and the formal agreement with White Horse Housing with respect to management of the affordable social housing.

Further to the discussion, **Councillors resolved to wholeheartedly support this application; FC/JP – 7 in favour with one abstention (GM). \*Clerk**

**PL/2022/01293** – Squalls Cottage, 27 Squalls Lane, Tisbury, SP3 6RX

Replacement of existing dwelling and change of use of agricultural land to domestic curtilage

Councillors considered this application in light of the Conservation Officer's comments and subsequent objection, before **resolving to OBJECT unanimously; RB/JP \*Clerk**

**b. Other Planning Matters:**

**i. Updating TisPlan (Neighbourhood Plan)** – Councillor GM summed up recent actions:

- Ros/IvyBlue to be approached for design work on leaflets for community engagement and survey forms. **\*GM**
- The scope of Community Engagement would be determined. **\*SD/CW**
- The Housing Needs Survey by AECOM had proved to be a mathematical conundrum and Consultant D. McCann had advised looking at the viability of the Station Works site in particular; also any other potential sites. **\*Consultant JA**  
Note: For the Station Works site, the viability would include access by a bridge across the railway line.
- Advice from D. McCann on the Environmental Plan would be covered separately.

**ii. Events for the Platinum Jubilee** –Councillor JP reminded everyone of the Tree Planting ceremony on 16<sup>th</sup> March and also asked Councillors to note the draft programme that was still subject to change.

The Road Closures for the 3<sup>rd</sup> and 5<sup>th</sup> of March would be submitted before April.

Update of Bowls Club lease to incorporate the newly formed Croquet Club – **Councillors resolved** that a clause to be added to ensure intended vehicle access over the Lower Recreation Ground to the Bowls and Croquet Club or the play area should be discussed with the Football Club Chairman as a matter of courtesy to ensure that no matches are likely to be disrupted or pitch damaged.
